Supervisor Report: Marijuana Tax Revenue received for 2021 was **\$112,906.88**.

Motion of approval to purchase the Splash Pad for Eagle Park for **\$32,732.00** with **\$24,000.00** being returned from the Grant. Motion to approve was made by Dawson and seconded by Siwecki. Roll Call Vote Dawson-aye, Gabriel-aye, Siwecki-aye.

Accident Fund Insurance Update - **\$27,884.00** extra this year.

Roof Repairs needed, working on getting estimates for new roof or resurfacing of the roof on the Township Hall.

Building and Zoning Department: Shelly Pinkelman reported that for the month of February \$595.00 collected in Building Department. The Zoning Department collected \$0.00. \$40,600.00 was collected for Marihuana.

Zoning Enforcement: Nothing currently.


