REGULAR MEETING

October 13, 2021

The meeting was called to order at 5:30 p.m. by Supervisor Gabriel. Roll call with five (5) members present, B. Gabriel, A. Siwecki, K. Dawson, D. Friedman and R. Richardson. There was one (1) citizen present Doug Pratt. There was two (2) video participants, Deb Friedman and David Kincaid.

The pledge of Allegiance was said.

Motion was made to approve the agenda. Motion was made by Gabriel and second by Richardson. Motion carried with five (5) ayes and zero (0) nays.

Motion was made to approve the Minutes from the September 8, 2021 regular meeting. Motion was made by Dawson and second by Friedman. Motion carried with five (5) ayes and zero (0) nays.

There were no public comments on the agenda items.

Clerk's Report: Motion was made to approve the Clerk's Check Register for September 2021, with paid check and EFT's **45714** thru **DD9758(A)** in the total amount of **\$246,626.80**. Motion was made by Dawson and second by Richardson. Motion carried with five (5) ayes and zero (0) nays.

Treasurer's Report: Motion was made to approve the Treasurer's Report. Motion was made by Siwecki and second by Friedman. Motion carried with five (5) ayes and zero (0) nays.

Supervisor Report: Discussion of the repaving and a 475 ft. expansion of the pavement at the Hulbert Road Bridge to just past the ORV trail.

Motion to except the CCRC bid in the amount of **\$19,695.90** for Hulbert Road with a 50% match of **\$9,847.95 from our Metro Fund**.

Motion made by Gabriel and seconded by Friedman. Roll call vote: Gabriel-aye, Siwecki-aye, Richardson-aye, Dawson-aye, Friedman-aye. Motion carried with five (5) ayes and zero (0) nays.

Building and Zoning Department: Pinkelman reported nothing for the Planning Commission. Zoning collected \$350.00. Building Department: collected \$5,703.25.

Fire and EMS Report: There was a total of 169 calls for the month of September. One structure fire on Kolka Creek Road.

Parks and Recreation: They had a meeting October 6, 2021. Trunk or Treat October 31, 2021 from 6-7 p.m. at the Betty Sajadak Park in downtown Frederic.


Zoning Enforcement: Have had calls on vandalism in our Eagle Park.
